Let Us Know About Life Support

If you have anyone on life-support systems at your residence, please notify Highline. The co-op will try to notify all consumer-members on life-support systems of any planned outages. Highline will not terminate a service if a licensed physician makes a certification in writing of a medical emergency. This continuance of service will be effective for 60 days from the date of said medical certification. One 30-day extension may be granted if a second medical certification is received prior to the expiration of the initial continuance period. These provisions may be used only once during any period of 12 consecutive months.

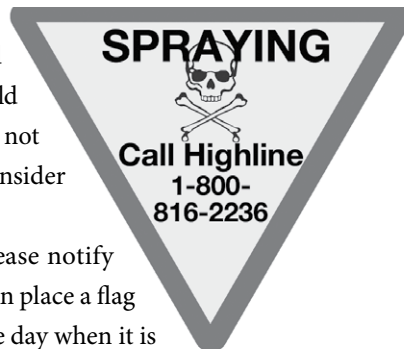

Please protect our employees

Our employees face serious health risks when they unknowingly enter a field that was sprayed or chemigated with any chemical. Just as you would not subject your family or employees to risk, we do not want to subject our employees to risk. Please consider the following:

- If you used any chemicals on a field, please notify Highline. You may call the office or you can place a flag at the entrance to the field. Please note the day when it is safe to enter the field and what chemical was used.
- Notification signs or flags are available free of charge at any Highline office.
- If calling during in an outage, please notify Highline if the field was sprayed.
- The initial and long-term effects of absorbing chemicals in the body are extremely hazardous to one’s health. Please don’t subject our employees to these dangers.

FARM SAFETY EQUIPMENT REACH

Make sure EVERYONE is trained on safe practices around electricity. Utilize these safety tips for you, your employees, seasonal workers, family members, and anyone else accessing your farm.

- Know the dimensions of any far-reaching equipment, such as chemical sprayers, tillage equipment, other extensions or augers.
- Machinery extension dimensions include length when extended horizontally and upright for transport.
- Always use the lowest (shortest) setting for extensions when moving loads.
- These power-line safety principles also apply to arms, booms, truck beds, ladders and other items or mechanisms that extend, lift, or are far reaching.

If your equipment does hit a power line, pole, or guy wire, do not leave the cab. Immediately call 9-1-1, warn others to stay away, and wait for the utility crew to cut the power.
