### JOIN K.C. ELECTRIC'S GRASSROOTS PROGRAM

hink back 85 years ago to 1936. The world was quickly changing, and innovations were being introduced that would reshape our way of life forever. Electric grids were being developed, bringing power to towns and cities across the West. Along with this grid development came the convenience of lights, washing machines, refrigerators and many other electric devices that we take for granted today. Electricity in homes and businesses increased convenience, quality of life and prosperity to those who had access to it. Many rural areas like ours were literally being left in the dark due to expected low profitability, which didn't look attractive to large investor-owned utilities that were developing these electric grids.

In 1935 President Franklin Roosevelt issued Executive Order 7037, which created the Rural Electrification Administration, and in 1936 Congress passed the Rural Electrification Act, which was a major step for rural America.

Instead of looking at profits, local leaders took advantage of this new approach and sought federal funds to electrify our rural area. Records indicate a discussion was held at a Flagler Farm Bureau meeting in 1942 to organize an REA cooperative in our area.

As the process evolved, K.C. Electric's founding members initiated a grassroots movement for rural electrification through which each member would become personally invested in the co-op. The "sign up" for REA began in 1945, and the Kit Carson Electric Association (later changed

to K.C. Electric Association) was incorporated in 1946.

This grassroots effort of our founding members was the first step that led us to where we are today: a nonprofit electric cooperative owned by our consumer-members. The incorporation of K.C. Electric made electricity available to our rural communities, increased our quality of life and provided consumer-members the means to expand the agricultural community that we enjoy today.

### Each of us has a voice that must be heard so our rural communities continue to thrive.

Today we have access to safe, reliable and affordable electricity. But our work is not done. New legislation continues to be introduced and passed that has the potential to negatively impact our local economies and way of life. As cooperative members, we all have a voice, and our voice needs to be heard by legislators so our values and way of life continue to thrive.

I'm asking you to join our grassroots effort now and use your voice to support our rural communities, economy and way of life. Joining is easy. Simply select the Community tab on our website www. kcelectric.coop, scroll down to Grassroots and fill out the online form. If you don't feel

### Q & A WITH THE BOARD: ERIC POSS



Eric Poss represents Lincoln County on the K.C. Electric Association Board of Directors. This is the second in a series that will run here in Colorado Country Life and is one way for consumer-members to become familiar with their board of directors.

#### Tell us about yourself and your family.

I was born and raised in Hugo. I graduated from high school in Hugo and attended college at the University of Wyoming where I met my wife, Rhianna. I completed school and came back to Colorado and began farming as a third-generation family member with my father and mother, Fred and Joie Poss, and my brother and his wife, Scott and Emily Poss, on the farm that has been in our family since 1946. Rhianna and I have two children: Cy, who is 8 years old and Charli, who is 7 years old. We run a cow/calf operation along with raising feeder cattle. We grow wheat, corn, proso and feed for the cattle operation.

### Why did you make the decision to run for the K.C. Electric Board of Directors?

I think it is important to get involved in different businesses in small communities. Cooperatives are what rural communities are about and they are what keep our communities strong and affordable. Cooperatives equate to ownership of a vital piece of our day-to-day lives in rural communities and therefore it is passed on to other entities of our rural life.

#### What strengths will you bring to the K.C. Board of Directors?

I have something to add as a younger generation that runs a small business, and can contribute by making difficult but good, solid decisions. I feel that cooperatives must make hard decisions every day concerning what is best for their members, and we make hard decisions every day on the farm. I feel I can contribute in a positive way in that regard. I can learn by getting to know our linemen and other personnel and what they do every day. This will help me to try to make the right decisions to help our consumer-member-owned cooperative by having a good understanding of the workings of the operation from the ground up.

### What are the major challenges you believe K.C. Electric will face in the future?

Tri-State Generation and Transmission is seeing drastic changes every day in the renewable market and legislation, which, in turn, are creating challenges that affect every facet of the electric industry. This, at times, puts a larger burden on rural electric cooperatives like K.C. Electric Association to keep rates as low as we can for our consumer-members and ensure that our electric supply is sustainable and reliable for the future.

### What are your thoughts on the status of the electric industry in Colorado?

I have seen in my short time on the board how renewables are the driving force in the industry and how they affect us in terms of supply, as well as legislation and regulatory aspects.

### What industry changes do you believe will affect the electric industry in the next 10 years?

- Coal use regulations
- Battery use as an energy source
- Technology in the day-to-day energy industry
- Renewables

### What do you feel you would like to accomplish as a director for K.C. Electric Association?

Short term: Learn more about the energy industry. Due to COVID, it is hard to learn from in-person networking and being able to access others for the valuable knowledge that they can convey in that regard.

Long term: Fight for the small communities and teach others that we matter, be a strong, solid voice for our rural communities. Work to keep electricity affordable for all the rural communities, and the consumer-members of the REAs.

### What is the greatest concern you have for the electric industry and how it will impact eastern Colorado?

Ensure we have a solid, ample electricity supply to fit our rural demand due to the need to sustain our way of life, which, in turn, keeps it affordable for all. Renewables are the biggest thing I see that could be a positive as well as a burden due to affordability, and this affects our rates to our consumer-members. Keeping our costs down is the key to our rural communities being able to stay in business, and with affordable electricity that is one important part to achieving that goal.

A medical reportable incident is an incident that requires medical treatment beyond basic first aid. This is quite an accomplishment, considering the extreme weather and dangerous conditions employees work in daily to keep the lights on. "Safety is our cornerstone," K.C. Electric General Manager David Churchwell said. "I am very proud of the culture of safety that has developed over the years at K.C. Electric and the professional service our employees provide on a daily basis for our membership."
