

LETTER FROM THE GENERAL MANAGER

What Renewable Energy Looks Like for MCREA

MCREA is proud to be a cooperative member of Tri-State Generation and Transmission Association, which provides power to 42 electric distribution cooperatives and public power districts across four states. Through this cooperative model, resources are pooled to develop larger, utility-scale renewable energy projects such as wind farms and solar arrays. This allows MCREA and other electric cooperative members to enjoy the benefits of renewable energy without shouldering the cost and responsibility for development alone. Currently, approximately one third of energy consumed by Tri-State members' retail customers comes from sustainable energy.

In January 2020, Tri-State released its Responsible Energy Plan. One of Tri-State's main goals is to have 50% of the electricity its members use come from renewable energy resources by 2024. By 2030, Tri-State aims to supply 70% of energy to Colorado member co-ops through renewable resources. The cooperative made progress toward that goal in 2020, as it started receiving power from the first of its 1,000 megawatts of new wind and solar projects, which will double Tri-State's renewable resources by 2024.

The following projects comprise the 1,000 MW of renewables that Tri-State plans to bring on line by 2024:

- 2021: Crossing Trails Wind (CO), 104 MW
- 2021: Niyol Wind (CO), 200 MW
- 2022: Spanish Peaks Solar (CO), 100 MW
- 2023: Spanish Peaks II Solar (CO), 40 MW
- 2023: Dolores Canyon Solar (CO), 110 MW
- 2023: Coyote Gulch Solar (CO), 140 MW
- 2023: Axial Basin Solar (CO), 145 MW
- 2023: Escalante Solar (NM), 200 MW

Through membership with Tri-State, MCREA will be able to distribute a portion of that clean energy to our consumer-members. MCREA values Tri-State's efforts to incorporate renewables into its energy sources because, in turn, our consumer-members are able to receive the benefits of evolving technologies in the power industry.

MAKING YOUR HOME SAFE & EFFICIENT

hether you're working from home, learning from home or just spending more time at home, it is important to make sure your home is electrically safe, secure and efficient. Learn how the internet of things and smart devices can improve your quality of life and make your home safer.

HOME ENERGY USE

Average energy use by item:

- Air-conditioning: 17% of total home energy use
- Space heating: 15% of total home energy use
- Water heating: 14% of total home energy use
- Lighting: 10% of total home energy use

PREPARE YOUR HOME FOR SAFE AND EFFICIENT ENERGY USE

- Use a smart plug or power strip to turn off power when devices are not in use
- LED lightbulbs last longer than traditional bulbs and use 25%-80% less energy
- Heat only the area you're in with energy-efficient space heaters
- Utilize home automation to control heating, cooling and lighting systems while not at home

HOME ELECTRICAL SAFETY DEVICES

- AFCI breakers and outlets protect against arc faults, which could lead to fires
- Grounded outlets protect against electric shocks
- GFCI outlets and breakers are required where water and electricity may come into contact to protect against ground faults
- Surge protective devices protect against damaging power surges that can destroy electrical equipment
