WHAT TO EXPECT WITH RATES

Highline Electric Association's wholesale power provider, Tri-State Generation and Transmission Association, submitted an updated wholesale rate structure to the Federal Energy Regulatory Commission in early June. This rate, which is based on Tri-State's 2024 budget, represents a 6.6% average rate increase for Tri-State. While the average rate increase for Tri-State is 6.6%, the rate increase for HEA will be approximately 7.6%. HEA's rate increase is different than the average for Tri-State because Tri-State's rate filing modifies the billing based upon the load profile of each of its member cooperatives.

The best analogy that I can use to explain this change is to ask you to consider the different quantities measured by a speedometer and an odometer. While they are related, they are not the same thing. The speedometer measures how fast you're going at a given moment, while the odometer measures how far you have traveled over a period of time. In electrical billing, the speedometer is like demand or capacity, and the odometer is similar to energy. In the world of electrical metering, we relate these two quantities through the use of a concept called "load factor."

Consider the case of two cars. The first covers a 100-mile distance by traveling at a speed of 20 miles per hour for five hours. The second covers the same 100-mile distance by traveling at a speed of 100 mph for one hour. When comparing this to the electrical world, the first car would be considered to have a very high load factor while the second car demonstrates a low load factor.

Now consider two electrical systems. The first delivers 100 kilowatt-hours of energy to a

20-kilowatt load running for five hours. The second delivers the same 100 kWh of energy, but this time the load is 100 kW and runs for an hour. It makes sense that it takes more investment in the second system to provide the capacity necessary to serve the load. The first example is a high load-factor load while the second example is a comparatively low load-factor load.

The adjustments made to the rate that Tri-State filed with FERC shifted some costs from high-load-factor systems to low-load-factor systems. If a Tri-State member system has a lower-than-average load factor, like HEA does, their rate increase will be higher than the average.

The rate that Tri-State filed at FERC may or may not be its final rate. There is likely to be a great deal of debate between all interested parties before the commission makes a final decision on Tri-State's rate. In fact, I won't be surprised if this process goes on for a couple of years. In the meantime, HEA will complete a cost-of-service study and rate design. The goal of the cost-of-service study is to allocate all of HEA's costs, including purchased power, to each rate class equitably. This means that the rate increase will likely be different for each rate class.

As I've mentioned here before, HEA has a significant amount of deferred revenue at our disposal that the board could decide to use to offset part of the rate increases that may be necessary over the next few years. I will continue to communicate with you over the next few months as this process plays out and we have a better understanding of HEA's 2024 rates.
