# THE CLIMB

had the opportunity to hike the Manitou Incline earlier this summer in conjunction with a meeting I was attending in Colorado Springs. If you haven't heard of the Incline (I had not prior to this meeting) and you're an outdoor fitness type (which I am not), I encourage you to check out this unique trail in southern Colorado. The Incline ascends on the east slope of Rocky Mountain, which is itself on the eastern flank of Pikes Peak. It is the remains of a narrow-gauge railway whose tracks washed out during a rockslide in 1990. The trail begins at an altitude of 6,500 feet and rises to 8,590 feet over a horizontal distance of 0.9 miles.

It occurred to me after I had completed the hike and had a fair amount of time to recover that the physical challenge presented by the Manitou Incline in many ways parallels the physical, mental, and/ or emotional challenges we face in our personal and professional lives daily. The first of these parallels occurred to me as we were approaching the Incline on the bus ride that morning. I was struck by a sense of foreboding, and I've experienced the same sinking feeling in my gut on several occasions when I embarked on other projects in my life. The takeaway for me on this point is pretty simple — you just have to take the first step. All the obstacles that we face in life can seem insurmountable until we dive in and get to work. It's been my experience that I have often made the obstacle bigger in my mind's eye. I think we are much better able to judge the size of the obstacle, or project, after we take that first step and get a better understanding of what lies ahead.

The second parallel that I drew from this experience is the idea of off-ramps or bailouts. There are three different bailouts along the Incline trail that allow you to exit to a gentle trail leading back to the base of the

mountain. I would be lying if I didn't tell you that I didn't give some pretty serious consideration to turning back at the third bailout. In fact, I can't say for sure that I wouldn't have turned back if not for the encouragement of the friends I was with. We need to allow ourselves the option for off-ramps in our personal and professional lives, too. Taking a few moments to take stock of our current situation and determining that we're still on the right path helps to reassure us that we're using our time wisely.

During the hike, there are several opportunities to step off the trail, turn around, and take in the amazing views. Those views are there because of the work that has been put in to get to that point on the trail. There are times in our lives when we get so engrossed in the here and now that we can start to lose perspective. There is value in taking a few minutes on occasion to step back and take in the view that our journey has led us to.

As I look back at my journey so far, I'm thankful for the perspective and the incredible views it has provided.


